Organic Association of Kentucky to Receive \$4.4 million for Climate-Friendly Practices Among Farmers

OAK has been tentatively selected to receive more than \$4.4 million to help hundreds of Kentucky farmers learn about and adopt climate-smart practices to improve soil health and water quality, reduce greenhouse gas (GHG) emissions and promote wildlife habitat. This project will center organic practices as part of our region's climate strategy. A significant portion of the funds will be distributed directly to farmers to implement and maintain practices that improve soil health and will support on-farm technical assistance. Climate-smart practices including cover cropping, reduced tillage, rotational grazing, agroforestry and others will be incentivized.

Historically underserved farmers – including limited-resource, beginning, socially disadvantaged and veteran farmers – will make up a large portion of the beneficiaries, and many more will be operators of "small farms," with gross annual

farm income under \$250,000. The project and partners will encourage emerging markets for Kentucky crops and livestock grown and raised using climate-smart practices.

The award is part of Partnerships for Climate-Smart Commodities, the U.S. Department of Agriculture's \$3.1 billion grant program aimed at expanding markets for America's climate-smart commodities and providing direct, meaningful benefits to production agriculture, including for small and underserved producers. OAK anticipates a Fall 2023 launch for this new program. We'll have more information about how you can participate later this year. OAK Joins National Partners to Highlight Farmer Voices on Organic & Small Farm Policy

Organic Trade Association

In early 2023 OAK join the Organic Trade Association and gained a farmer seat on the Farmers Advisory Council (FAC). The Organic Trade Association (OTA) is the membership-based business association for organic agriculture and products in North America. OTA is the leading voice for the organic trade in the United States, representing over 9,500 organic businesses across 50 states. Its members include growers, shippers, processors, certifiers, farmers' associations, distributors, importers, exporters, consultants, retailers and others. OTA's Board of

Directors is democratically elected by its members. OTA's mission is to promote and protect ORGANIC with a unifying voice that serves and engages its diverse members from farm to marketplace.

The Organic Trade Association's Farmers Advisory Council (FAC) provides the Organic Trade Association Board of Directors and staff with input from small-and medium-sized organic farmers, ranchers, and growers on matters pertinent to the advancement of organic agriculture, with a specific focus on OTA's policy agenda. Established in 2013, FAC was designed to formalize and improve communication between OTA and organic producers. Through open dialogue, FAC gives organic farmers a voice to directly influence OTA's policy and enables OTA to better represent the diversity of organic producers in its policy and advocacy.

OAK farmer members whose income from farming is less than \$250,000 per year (aligned with USDA definition of "small-farmer") will be eligible for OTA's Farmstead membership and may choose to become a direct member of OTA for an annual membership fee of \$50.

Organic Farmers Association

In 2022 OAK's Executive Director, Brooke Gentile, began a 2-year term on the Organic Farmers Association Governing Council. Participation in OFA meetings and events creates opportunities to elevate the opportunities and challenges we are experiencing in Kentucky organics to a national conversation. In early

March, Brooke will gather with OFA Policy Council and Governing Council in Washington DC to share organic policy priorities with our representatives.

New Fruit Scout Website allows easier access to IPM Scouting Guides

The University of Kentucky's IPM Scouting Guide publications for fruit crops were converted into mobile compatible websites beginning in 2017. Now accessing this information is even easier with the creation of the Fruit Scout Website. This new website provides access to the information found on the Apple, Bramble, Grape, Peach, and Strawberry Scout websites all in one place. The Fruit Scout Website is available for grower, agent, and homeowner use and can be accessed from any phone, tablet, iPad, or computer.

USDA Invests \$9.4 Million in Compost and Food Waste Reduction Projects

USDA is investing more than \$9.4 million in 45 cooperative agreements that support innovative, scalable waste management plans to reduce and divert food waste from landfills. The Compost and Food Waste Reduction (CFWR) cooperative agreements, which are funded by the American Rescue Plan Act, are part of USDA's broad support for urban agriculture through its Office of Urban Agriculture and Innovative Production (OUAIP). The projects will be implemented between 2023 and 2025. Read more here.

USDA Nationwide Survey for Prospective Farmers, Ranchers and Forest Managers

All farmers, ranchers and forest managers are encouraged to take the survey. Existing customers and prospective customers both provide unique perspectives they'd like to hear. They'd especially like to hear from a new audience this year

of prospective customers, those who don't know about USDA farm programs or have yet to work with them, and those who were unable to participate in the past.

Kentucky Leopold Conservation Award Seeks Nominees

Are you a Kentucky farmer or forester who improves soil health, water quality, and wildlife habitat on your working land? Apply for the 2023 Kentucky Leopold Conservation Award®.

Sand County Foundation and national sponsor American Farmland Trust present the Leopold Conservation Award to private landowners in 25 states for extraordinary achievement in voluntary conservation. In Kentucky, the \$10,000 award is presented annually with the Kentucky Agricultural Council and the Kentucky Association of Conservation Districts.

Resources and Funding for Farmers

The U.S. Department of Agriculture (USDA) is making available up to \$7.5 million for grants through its **Office of Urban Agriculture and Innovative Production (OUAIP).**

The competitive grants will support the development of urban agriculture and innovative production projects through two categories, Planning Projects and Implementation Projects.

<u>A pre-recorded webinar on Urban Agriculture and Innovative Production Grants</u> <u>| USDA</u> provides an overview of the grants' purpose, project types, eligibility and basic requirements for submitting an application.

Deadline to apply March 27, 2023

Silvopasture and Forest Farming Support / Funds Available

The Catalyzing Agroforestry Grant Program is focused on implementing silvopastures and forest farming practices through direct support payments and will assist producers in designing appropriate projects using technical assistance and science-based planning strategies. The ultimate goal of the effort is to increase ecosystem sustainability and diversity by scaling up agroforestry practices. The Appalachian Beginning Forest Farming Coalition (ABFFC) project will provide up to \$1500/acre for silvopasture implementation and up to \$1000/quarter acre for forest farming implementation depending on project scale and scope. To enhance shared learning, producers who receive support will share successes and lessons-learned with their peers and other interested stakeholders. Minority, female, Indigenous, LGBTQ+, and/or socially disadvantaged farmers are highly encouraged to apply.

USDA Offers Assistance to Protect Privately-Owned Agricultural Lands

The U.S. Department of Agriculture (USDA) encourages people and groups wanting to protect agricultural lands to consider enrolling their property into conservation easements.

The Agricultural Conservation Easement Program – Agricultural Land Easements (ACEP - ALE) focuses on protecting and conserving productive agricultural lands. Landowners are compensated for enrolling their land in easements. Partners include state or local agencies and certain non-profits. Eligible lands include privately owned cropland, pastureland and forestlands. Landowners do not apply directly to NRCS for funding under this program. Applications from eligible entities for 2023 ACEP-ALE funding must be received by December 1, 2022 to be considered for the current funding cycle. Landowners who wish to be considered for ACEP-ALE must make application to an eligible entity. Entities interested in agricultural easements should contact their local USDA service center or visit the Kentucky NRCS ACEP-ALE website.

Slow Food Bluegrass Garden Grant

Deadline: ongoing

Slow Food Bluegrass micro-grants support groups in Kentuckiana who foster education about and access to good, clean, fair food. Special priority is given to limited resource communities and to projects that demonstrate a strong buy-in from participants. Grants range from \$500 - \$1,000 and may be awarded throughout the year. KSU Small Scale Farm Grant

Deadline: The 1st day of every other month

Funding Amount: Up to \$5,000 for farmers, \$15,000 for groups benefiting multiple farmers Eligible Entities: Kentucky farmers and Kentucky agriculture groups including farmers markets

Overview: The KSU Small Scale Farm Grant is designed with the small operation farmer in mind. This grant application is relatively simple to complete and the funds can be used to purchase needed equipment related to the proposed project. To qualify, applicants must be producing a value-added product, be an organic farmer, and/or be an aquatic farmer. Farmers markets are often eligible. Previously approved projects have included canning equipment, a walk-in cooler, a water line to a hoop house, a root cellar, a cool-bot for vegetables, and a trailer for keeping meat cool and recently added farmer education assistance with a maximum of \$500.

Kentucky Proud Promotional Grant

Deadline: On-going

Funding Amount: Up to 10% annual gross farm income, max at \$8,000 per year; \$1 for \$1

match

Eligible Entities: Kentucky farmers and agribusinesses **Link**: http://www.kyagr.com/marketing/grants.html

Overview: The Kentucky Proud Promotional Grant is a cost share program to help Kentucky farmers and agribusinesses pay for advertising and marketing expenses. The award amount is based on 10% of direct farm impact; for a farmer it would be 10% of their total farm gross sales. The applicant must be a registered member of Kentucky Proud to apply and use the Kentucky Proud logo/brand in marketing efforts paid for with program funds. Examples of fundable items include TV ads, radio ads, web expenses, hats, t-shirts, demos, sampling, labels, packaging, tradeshows, UPC, and bar codes. This is a great program that helps promote our local farms!

ON-Farm Energy Efficiency Incentives Program

Deadline: Applications are accepted year round

Funding Amounts: 50% cost share - up to a \$10,000 incentive, plus \$150 for an approved

third party energy audit

Eligible Entities: Kentucky farmers with a gross farm income of at least \$25,000

Overview: The Kentucky Agricultural Development Fund offers an On-Farm Energy Efficiency Program to help Kentucky farmers with energy projects. These cost share funds are available to increase on farm energy efficiency and to support renewable fuel production projects. The applicant is required to have a third party energy audit completed. This program can be combined with the USDA-NRCS Rural Energy for America Program (REAP) to get up to 75% of a total project cost covered.
