## **Not-To-Miss Opportunities**

#### Farmers, Join Your Local FSA County Committee!

The U.S. Department of Agriculture (USDA) is now accepting nominations for county committee members for elections that will occur later this year. **All nomination forms for the 2023 election must be postmarked or received in <u>your local FSA office</u> by Aug. 1, 2023.** Farm Service Agency County Committees are a critical component of the day-to-day operations of FSA and allow grassroots input and local administration of federal farm programs.

County committee members make important decisions on how federal farm programs are administered locally. The committees are made up of three to 11 members who serve threeyear terms. Committee members are vital to how FSA carries out disaster programs, as well as conservation, commodity and price support programs, county office employment and other agricultural issues.

Elections will occur in certain Local Administrative Areas (LAA) for members. LAAs are elective areas for FSA committees in a single county or multi-county area and may include an urban or suburban area.

Customers can locate their LAA through a <u>new GIS locator tool</u> available at <u>fsa.usda.gov/elections</u>.

Agricultural producers may be nominated for candidacy for the county committee if they:

- Participate or cooperate in a USDA program; and
- Reside in the LAA that is up for election this year.

A cooperating producer is someone who has provided information about their farming or ranching operation to FSA, even if they have not applied or received program benefits. Individuals may nominate themselves or others and qualifying organizations may also nominate candidates. USDA encourages minority producers, women and beginning farmers or ranchers to nominate, vote and hold office. **OAK encourages all farmers in our community to apply!**

Build Local Food Networks Across KY Funding to build resilient local food production, aggregation, distribution and consumption pathways to combat susceptibilities to supply-chain disruption.



Strengthen Prepared Meals Programming Directly strengthening the impact of incorporating local foods into existing prepared meal programs:

- Seeking profitable procurement relationships with historically socially disadvantaged farmers
- Improving meal nutritional quality with a larger variety of ingredients, increasing community health

Expand Available Distribution Networks Managing cooperative agreements expanding Kentucky's distribution pathways to accessibly deliver high quality, local foods to low-income and underserved communities.



Kentucky's LFPA program is designed to maintain and improve food and agricultural supply chain resiliency through strategic **local food purchasing and distribution** mechanisms with partners like Feeding Kentucky. Federal funds administered by the Kentucky Department of Agriculture (KDA) will be used to purchase local and regional foods produced within the state (or within 400 miles of the delivery location) and distribute them to low-income or underserved communities to increase access to healthy, nutritious, and local products. A wide variety of products will be purchased from local producers, like fruits, vegetables, seafood, meat, poultry, eggs, etc. that are fresh, raw, and significantly or minimally processed. The program prioritizes sourcing local products from Kentucky's socially disadvantaged producers.

Feeding Kentucky is currently prioritizing procurement of local animal protein products (eggs, meat, etc.) from farmers and growers for Local Distribution Agencies. ## Assistance For USDA Farm Loan Borrowers Who Have Faced Discrimination

#### Financial Assistance Application Process Now Open!

The U.S. Department of Agriculture (USDA) announced the opening of the financial assistance application process for eligible farmers, ranchers, and forest landowners who experienced

discrimination in USDA farm lending programs prior to January 2021. Section 22007 of the Inflation Reduction Act (IRA) directs USDA to provide this assistance.

Farmers, ranchers, and forest landowners who experienced discrimination by USDA in its farm loan programs prior to January 1, 2021 and/or are currently debtors with assigned or assumed USDA farm loan debt that was the subject of USDA discrimination that occurred prior to January 1, 2021, are eligible for this program. To apply, borrowers have the option to apply via the e-filing portal at <u>22007apply.gov</u> or submit paper-based forms via mail or inperson delivery to the program's local offices. The application process will be open until October 31, 2023. The DFAP Call Center will assist applicants with general inquiries and answer questions in completing an Application. Reach them by email at <u>info@22007apply.gov</u> or phone at 1-800-721-0970.

To support producers throughout the application process, USDA is ensuring that organizations with extensive experience conducting outreach to farm organizations are able to support individuals who may be eligible for the program. These groups include <u>AgrAbility</u>, <u>Farmer Veteran Coalition, Farmers' Legal Action Group</u>, <u>Federation of Southern</u> <u>Cooperatives</u>, <u>Intertribal Agriculture Council</u>, <u>Land Loss Prevention Program</u>, <u>National Young Farmers Coalition</u>, and <u>Rural Coalition</u>.

Please note: this application process is free, and you do not need a lawyer to apply!



## USDA National Organic Program Releases New Publication for Understanding "Strengthening Organic Enforcement"

Consumer confidence in the USDA organic seal has fueled industry growth and market expansion, according to the agency's National Organic Program (NOP), which is tasked with ensuring rules protect the organic market as it grows. The NOP has published the <u>Strengthening Organic Enforcement (SOE)</u> final rule to improve market protections, making it harder to cheat the system, according to the NOP.

"SOE protects the integrity of the organic supply chain and builds consumer and industry trust in the USDA organic label by strengthening organic control systems, improving farm to market traceability, and providing robust enforcement of the USDA organic regulations," according to a USDA news release. To help organic certifiers and operations comply with the rule, NOP has published a new <u>SOE reference resource</u> online.

## **Educational and Farming Support**

Apply for Organic Dairy Marketing Assistance Deadline is July 26, 2023 The Organic Dairy Marketing Assistance Program (ODMAP) was created to assist certified organic dairy producers facing a unique set of challenges in recent years, including higher costs attributed to the pandemic and drought conditions across the country. USDA's Farm Service Agency (FSA) is providing financial assistance for a producer's projected marketing costs in 2023 based on 2022 costs. ODMAP provides a one-time costshare payment, based on marketing costs, on pounds of organic milk marketed in the 2022 calendar year.

Organic dairy producers should apply by July 26, 2023 at their local USDA Service Center. <u>Learn more</u>.

#### Clean Lakes, Estuaries, And Rivers initiative (CLEAR30) Deadline is July 31, 2023

CLEAR30 is an option available through the USDA's Conservation Reserve Program (CRP), which is one of the largest voluntary private- lands conservation programs in the United States. CRP was originally intended to primarily control soil erosion and stabilize commodity prices by taking environmentally sensitive lands out of production. The program has evolved over the years, providing numerous conservation and economic benefits.

Agricultural producers and landowners with certain expiring CRP contracts can receive additional rental incentives and extend that land's role in conservation for another 30 years.

CLEAR30 is a part of the CLEAR initiative, which prioritizes water quality practices as a part of Continuous CRP enrollment, and is one of several CRP enrollment opportunities. CLEAR30 allows producers and landowners enrolling certain water quality practices to enroll in 30-year contracts, extending the lifespan and strengthening the benefits of important water quality practices on their land. Like other CRP enrollments, CLEAR30 is a voluntary, incentive-based conservation opportunity offered by USDA's Farm Service Agency (FSA).

#### Kentucky State University's Small-scale Farm Grants Next deadline: August 1, 2023

Kentucky farms with sales between \$1,000 - \$250,000 in the previous two years are eligible for funds up to \$5,000. Priority areas for the grant are aquaculture/aquaponics, certified organic agriculture, value-added enterprise, food insecure area production, agroforestry, and farmer education assistance. #### Water Quality Testing through Kentucky State University

Kentucky State University has established regional water testing labs for farmers wishing to have their irrigation water sources tested. This is a voluntary program to help farmers become familiar with some of the water quality requirements that may be required under the Food Safety Modernization Act (FSMA). The water tests are 2 free to farmers, and results are available within one week of dropping off samples at the lab. Results can supplement farmers' Farm Safety Plan, Agriculture Water Quality Plan (AWQP) and other relevant recordkeeping needs.
